Bidders **MUST** meet the following requirements;

1. Attach a dully filled and stamped confidential business questionnaire
2. Attach Form of tender duly filled, signed and Stamped
3. Attach duly filled, signed and stamped certificate of independent tender determination
4. Must Submit a Tender Security of KES. 800,000 in any of the following forms; a bank guarantee; a guarantee by an insurance company registered and licensed by the Insurance Regulatory Authority listed by the Authority; a letter of credit; or guarantee by a deposit taking micro-finance institution, Sacco society, the Youth Enterprise Development Fund or the Women Enterprise Fund.
5. Must submit a self-declaration that the person/ tenderer will not engage in any corrupt or fraudulent practice.
6. Must submit a self-declaration that the person/ tenderer/firm is not debarred in the matter of the Public Procurement and asset Disposal Act 2015.
7. Attach valid current year business permits certified by commissioner of oaths/advocates
8. Attach valid current year tax compliance certificate certified by commissioner of oaths /advocates.
9. Attach certificate of incorporation certified by commissioner of oaths/advocates.
10. Attach PIN/VAT certificate from KRA certified by commissioner of oaths/advocates
11. Attach CR 12 form certified by commissioner of oaths/advocates
12. Bid Documents submitted **MUST** be sequentially numbered(serialized)
