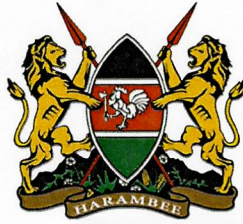

3. Interested bidders are required to pay a refundable deposit of Kshs.10,000.00 which is mandatory to get a bidding number. The deposit shall be paid in form of cash at the Office of the Attorney General & Department of Justice (State Law Office) cash office during normal working hours from 9.00 a.m. to 4.00 p.m.
4. The item/items bided and fully paid for must be collected within thirty (30) days failure to which the purchaser shall be liable to pay a storage charge of Kshs.1,000/- per day.
5. The items shall be sold on AS-IS-WHERE-IS basis.
6. The declared purchaser (highest bidder) MUST pay 25% of the purchase price in cash for the lots bided and the balance must be paid in cash within seven (7) days from the Auction day, failure to which the initial deposit will be forfeited and the item offered to the second highest bidder.
