1. Must submit a Copy of certificate of Registration/Incorporation
2. Must submit a copy of CR12 for Limited Companies & Partnership deed for Partnerships obtained not more than 12 months from the date of this advert and copies of Directors ID cards.
3. Must submit a valid Business Permit/License
4. Must submit a Copy of Valid Tax Compliance Certificate
5. Valid NCA Certificate Category 8 and above and Current NCA practicing license (Road works).
6. Must submit Tender Form dully Completed, Signed and Stamped by The Tenderer in the format provided.

7. Must submit a dully filled, signed and stamped Confidential Business Questionnaire in format provided
