Bidders **MUST** meet the following requirements alongside other requirements contained in tender documents.

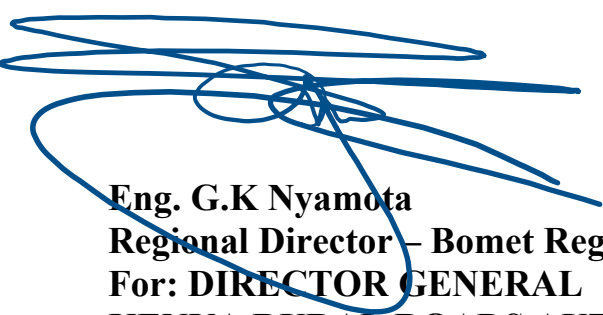

Bidders are requested to familiarize themselves with the site before tendering by making their own personal arrangements in consultation with the Regional Director's office and ensure that their pre-tender site visit certificates are signed and stamped by the Regional Director or his/her representative as clause 7.1 of instruction to bidders. The pre-tender site visit arrangements shall be on **24th June 2026**.
3. All Interested bidders **MUST** provide Original Tender Document
4. All Interested bidders are required to continually check the KeRRA website www.kerra.go.ke/tenders for any tender addendum or clarification that may arise before the submission date.
5. Certification of attachments must be done, dated and signed by a commissioner for oaths.
6. The cost estimate of the proposed works has been provided in the tender document.

7. All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
