Interested eligible bidders may obtain a complete set of tender documents from PPIP Portal, www.tenders.go.ke.

The following documents should be attached to form part of evaluation criterion:

1. Provide Proof of business incorporation or registration
2. Tenderer has a current tax clearance certificate or tax exemption certificate issued by the Kenya Revenue Authority. (Valid Tax Compliance Certificate)
3. A copy of company's list of directors, beneficial owners, name of proprietor or names of partners for the bidder not more than one year old (CR12). All Directors of both Limited companies and sole proprietor to attach ID COPY (ies). A sole proprietor may not attach a CR12.
4. Bid bond of Kshs.70,000 valid for 150 days from date of opening
5. Fully filled, Signed and Stamped Form of Tender. The tenderer MUST clearly show the Tender's complete name and business address. Tenderer's MUST complete and sign Confidential Business Questionnaire, Certificate Of Independent Tender Determination and the Self Declaration of the tenderer attached to the Form of tender.
6. Attach evidence of a valid registration with National Construction Authority (NCA) category 8 and above for building works and above with current annual practicing license.
7. The bid has been submitted in the format required by the procuring entity - the tender document to be TAPE bound and returned in the order and pages provided and paginated in sequence including attachments. Own pagination should begin from the very first page.
8. Valid copy of Trading License / Business Permit
9. Power of attorney (if Tender signatory is not a director)
10. Signed and stamped statement of Verification that not debarred in matters of public procurement proceedings (Must be commissioned by a Commissioner for Oaths)
11. Declaration that the firm has not been convicted of corrupt or fraudulent practices and that it will not engage in any corrupt or fraudulent practice

Note:

bidders with history of non- performance e.g failure to complete the projects within the contract period, termination of contract or having been issued with a notice of termination are ineligible to bid

Prices quoted should include all taxes and must be expressed in Kenya
