The County Government of Marsabit invites interested and eligible consulting firms to submit their Expression of Interest (EOI) for prequalification for the provision of consultancy services for Strategic Plan Preparation Consultancy Service for the Financial Year 2026-2027.

To be eligible for prequalification, consulting firms must meet the following mandatory requirements

MANDATORY REQUIREMENTS FOR THE EOI

- 1) Provide a proposal of Expression of Interest (EOI) of the Firm.
- 2) Provide Valid Certificates of Registration of the firm or entity.
- 3) Provide a Valid Certificate of Regulatory Body (Where Applicable).
- 4) Valid Business Permit for current year
- 5) A signed declaration that the firm has no conflict of interest in the proposed procurement proceedings and has not been declared ineligible or blacklisted by any Kenyan public entity
- 6) Provide Current organization Profile.

EVALUATION CRITERIA FOR PREQUALIFICATION

The EOI applications will be evaluated based on the following criteria. Only firms that meet the technical requirements and score above the minimum passing score will be prequalified.

Minimum passing marks: 70%

Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract if selected.

The completed EOI application must be submitted in **ONE ORIGINAL** and **ONE COPY**, bound and paginated.
